MINUTES CUERO DEVELOPMENT CORPORATION REGULAR MEETING TUESDAY, JANUARY 17, 2023 5:00 P.M.

The Cuero Development Corporation Board of Directors met Tuesday, January 17, 2023, at 212 E. Main Street, Cuero, Texas.

I. CALL TO ORDER

President Tyler McClellan called the meeting to order at 5:00 P.M.

II. <u>CITIZENS INPUT</u>

Mr. Russell Goebel thanked the CDC Board for their time and consideration of their proposed project. Mr. Goebel noted that with the assistance of the CDC, the Cuero Municipal Golf Course has increased their membership and club revenue, both of which are at a record high. It was noted that the Cuero Municipal Golf Course is utilized by many organizations which include schools, churches, community organizations, and the course brings quality of life to the citizens of Cuero. Mr. Goebel expressed the urgency of repairing the golf course completely versus repairing a small area that will cause additional problems.

III. MONTHLY FINANCIALS

Mr. Scott gave the financial report for the periods ending October 31, 2022 and December 31, 2022. Mr. Scott stated that the financials were in good standing and he would recommend approval.

IV. BUSINESS

CONSIDER AND ACT UPON AN APPLICATION FOR MAJOR PROJECTS FOR THE CITY OF CUERO PARK'S DEPARTMENT

Mrs. Cromeens presented this item to the Board, noting that two applications had been submitted by the City of Cuero, per her suggestion.

Mr. Danish thanked the Board for their continuous support of the City of Cuero's Golf Course Renovation Project. He reported that hole #5 and hole #6 are currently being renovated and hole #1 and hole #9 are awaiting the renovation process. The course is around 80-85% complete with the enhancements that were funded by the Cuero Development Corporation. Mr. Danish reported that the greens were refinished, but unfortunately did not survive due to the bleed through on the Bermuda grass. Mr. Danish expressed his concern that not properly addressing the grass issue could cause additional mishaps at the golf course. It was noted that Fairway #1 has had Platinum Paspalum for the last ten years and there haven't been any issues with the bleed through of the common Bermuda grass. The total cost of this partial project would be \$85,000.00.

President McClellan questioned how long the project is expected to take. Mr. Danish noted that the project would take 3-4 weeks with a 6 week max if the course was closed.

Mrs. Falcone questioned if there was a certain time of year that the project had to be done. Mr. Danish stated that it was best to install the grass when the soil is 60 degrees Fahrenheit.

Mr. Freeman commented that he was in favor of completing the project as a whole so that the course was addressed instead of fixing portions and having to readdress those spots.

Mayor Meyer questioned if Mr. Danish has seen any projects that were complete by the contractor. Mr. Danish said he hasn't, but the contractor was highly recommended by the grass vendor, RGR Golf Services, LLC.

Mr. Scott questioned if there was a downside to the grass project. Mr. Danish stated that during the summer months the grass tends to grow fast.

MOTION MADE BY <u>LYNN FALCONE</u>, SECONDED BY <u>GREG FREEMAN</u>, TO DISAPPROVE THE MAJOR PROJECTS GRANT APPLICATION FOR THE CITY OF CUERO PARK'S DEPARTMENT IN THE AMOUNT OF \$85,000.00 AYES: 7 NAYES: 0 MOTION CARRIED UNANIMOUSLY

CONSIDER AND ACT UPON AN APPLICATION FOR MAJOR PROJECTS FOR THE CITY OF CUERO PARK'S DEPARTMENT

The full project funding would cost \$177,250.00. This will include adding contours to the greens to help with standing water and adding a professional look to the greens. Upon completion of contouring the greens, RGR Golf Services LLC will re-grass all greens and surrounding areas. These additions to the Cuero Municipal Golf Course will make Cuero the best in the area.

CONSIDER AND ACT UPON TRANSFERRING FUNDS FROM TDECU TO THE CDC'S TEXPOOL ACCOUNT UPON MATURITY OF THE CURRENT CERTIFICATE OF DEPOSIT

Mrs. Cromeens recommended that the present CD of \$249,221.33 at TDECU be moved to TexPool with an interest rate of at least 4.5064% ON January 17, 2023. The CD maturity date was on January 13, 2023.

REVIEW OF THE BUSINESS START-UP + PROGRAM

Mrs. Cromeens gave an overview of the Business Start-Up + Program as requested by the Board. The updates to the application include: the applicant must have opened after January 1, 2022 and the second grant will provide up to 25% of the monthly rent for a maximum of \$250.00 per month for up to six months. The second grant will be available after CDC staff has verified that the business is still open and operating after six months.

CONSIDER AND ACT UPON CONTRACTING WITH LOCAL REAL ESTATE AGENT FOR UPDATED REAL ESTATE PROPERTY

Mrs. Cromeens reported that this item was not an action item, it was just a follow up from the December meeting as this item was tabled. Upon speaking with other local Economic Development Corporations, it was suggested that the CDC continue using ZoomProspector and that they continue acquiring the lease and purchasing information from local real estate agents and from commercial property owners to keep their site updated.

AUTHORIZE NAMES ON SIGNATURE CARDS FOR FIRST NATIONAL BANK OF SHINER

Mrs. Cromeens stated that the City of Cuero has gone through an RFP for bank depository services and First National Bank of Shiner was awarded. The CDC must have at least three signers on the account for any bank transactions.

PRESIDENT MCCLELLAN APPOINTED LYNN FALCONE, GREG FREEMAN, AND BEN ZIMMERMAN AS THE AUTHORIZED SIGNATORIES FOR THE CDC'S NEW ACCOUNT AT THE FIRST NATIONAL BANK OF SHINER.

Mrs. Cromeens noted that staff is looking into several avenues to better capture the business community's involvement, this may include a lunch or dinner similar to Community Leaders Meetings.
