DISCUSS ALTERNATIVE GRANT SUGGESTIONS AND OPTIONS

Mr. Seiferman stated that as previously mentioned at the April 27th Board Meeting, the CDC staff is seeking an alternative grant recommendation for those businesses that are not sales tax driven, but were forced to close their doors during the mandatory shutdown. Mr. Seiferman noted that he would recommend using the existing Rental Assistance and Small Business Assistance Programs with the exception of adding businesses such as daycares, hair & nail salons, massage therapy, and any additional industries as specified in the Governor's declaration. The additional application would still have a deadline of June 30, 2020.

Mr. Crain questioned if the additional non sales tax driven business types would be written out in the grant applications. Mr. Seiferman stated that the applications could be tailored to include the Board's recommendations.

The Board suggested that the alternative grant application be presented as an action item at the next Board Meeting.
