# MINUTES CUERO DEVELOPMENT CORPORATION REGULAR MEETING TUESDAY, SEPTEMBER 19, 2023 5:00 P.M.

The Cuero Development Corporation Board of Directors met Tuesday, September 19, 2023 at The City of Cuero Council Chambers, 214 E. Main Street, Cuero, Texas.

### I. CALL TO ORDER

President Tyler McClellan called the meeting to order at 5:00 P.M.

### III. MONTHLY FINANCIALS

Mr. Scott gave the financial report for the period ending August 31, 2023. Mr. Scott stated that the financials were in good standing and ahead of budget on the revenue and he would recommend approval.

Mr. Scott questioned if the CDC would cut a check for NestFresh before the end of the fiscal year. Mrs. Cromeens noted that the CDC has submitted the Performance Agreement to the NestFresh lawyers and they plan to hear back from them soon.

Mayor Meyer noted that the administrative line item was over budget. Mrs. Cromeens noted that Budget Amendment #2 has not been entered and these numbers will be reflective for the September financial statements.

#### IV. BUSINESS

## HEAR PRESENTATION FROM AARON FARMER OF THE RETAIL COACH

Mrs. Caroline Harrelson reported that The Retail Coach has been in a contract with the Cuero Development Corporation (CDC) for the last six months. The Retail Coach has presented at the Economic Development Summit, has attended ICSC Las Vegas, Retail Live! Austin, Retail Live! Carolina, and will attend ICSC Atlanta and ICSC Red River in Dallas on behalf of the CDC. Over forty (40) retailers have been contacted to share information regarding Cuero and their available sites and Mrs. Harrelson gave an update of the status of each retailer. Mrs. Harrelson assured the Board that as they get closer to closing out on conversations with each retailer, they will update the Board.

# HEAR PRESENTATION FROM ROBERT ROYER OF BUILDING BRANDS MARKETING

Mr. Royer gave a presentation on the Cuero Development Corporation's progress since contraction with Building Brands Marketing (BBM). Mr. Royer noted that the CDC has partnered with BBM for collaterals for the State Fair, the Economic Development Summit, ICSC Las Vegas, and for the South Texas Regional Job Fair. BBM has used techniques such as geotargeting, geofencing, search engine optimization, and SEM to create attraction for the CDC on social media and internet searches. This effort has allowed the CDC to grow their audience and has been proven beneficial. Mr. Royer reiterated that he has thoroughly enjoyed his working relationship with CDC staff and he would appreciate the continuation of working with the CDC.

Mrs. Cromeens stated that the CDC only received one bid for the Marketing Request for Proposal that was submitted. Staff recommended that the Board approve the Marketing RFP from Building Brands Marketing.

# HEAR UPDATE FROM DAVID SCOTT REGARDING CONVERSATIONS WITH WILLIAM HORNBERGER, JACKSON WALKER LLP

Mr. David Scott reported that while attending the 2023 Tax Summit in San Antonio, he was able to meet Mr. Willie Hornberger of Jackson Walker LLP. Mr. Hornberger was interested in Cuero and introduced Mrs. Cromeens, Mr. Scott, and Mrs. Bayfus to Mr. Sandor Galambos, Senior Investment Specialist at the U.S. Embassy in Bern, Switzerland via Zoom. Mr. Galambos travels with the Ambassador to the U.S. to help facilitate site selection for Swiss companies doing business in the U.S. Mr. Hornberger believes that Cuero is in a strategic location and has asked Mr. Galambos to consider a visit to Cuero. CDC staff has been invited to SelectUSA in Washington in June, 2024. Jackson Walker hosts a dinner at the St. Regis for the Swiss delegation and staff has also been invited to this exclusive event.

With the growth in the utilization of the Club, they plan to build a patio adjacent to the pool to create a cooling space for visitors. Mrs. Cromeens mentioned that in speaking with Wesley Kubesch, President, it was noted that he is able to sign the applications on behalf of the Cuero Country Club.

Mrs. Cromeens noted that Taqueria Jalisco is purchasing custom made furniture from Mexico for their restaurant. Erika and Jose Hernandez have run the restaurant for the last three years, but have recently purchased the building and they would like to add their own finishing touches.

Mayor Meyer questioned if the taxes were correct for the application. Mrs. Cromeens noted that CDC Staff retrieves the tax documents from the tax office. Mr. Zimmerman clarified that the tax document attached was for inventory taxes only.

Although the building is owned by Anthony and Shelly Rath, they have agreed to allow Classy B's to sub-lease the back of the building for the salon. A one year lease agreement in the amount of \$900.00 was signed on August 24, 2023.

Mrs. Cromeens stated that she was approached by the Cuero Turkeyfest Board regarding a sponsorship for the "Farewell Breakfast" for the Worthington, MN delegation. Mrs. Cromeens noted that in the past, the CDC has sponsored a meal for the Worthington Band.

Ms. Donels questioned if the sponsorship was budgeted. Mrs. Cromeens noted that she had a conversation with President McClellan and recommended that a new line item was added for sponsorships.

Ms. Donels questioned if the expense would be deducted from the current fiscal year or the upcoming FY 23-24. Mrs. Cromeens mentioned that she would prefer it come out of the upcoming fiscal year.

Mayor Meyer noted that in the past, the CDC paid for sponsorships and they would come out of advertising budget line item. She questioned if this would affect the 10% allocation that the CDC is allowed to spend. Mrs. Cromeens noted that the Marketing line item is restricted and these sponsorships would be advertising.

The Board requested that their sponsorship level include recognition for the Cuero Development Corporation.
