#### III. MONTHLY FINANCIALS

Mr. David Scott gave the financial report for the period ending July 31, 2020. Mr. Scott stated that he reviewed the financial reports and all accounts are in good standing. #### IV. BUSINESS

### HEAR PRESENTATION FROM ROBERT OLIVER ON THE CHISHOLM TRAIL HERITAGE MUSEUM'S EXPANSION PLAN

Mr. Oliver and Mrs. Weber presented the Board with a draft drawing and slideshow of the upcoming expansion project of the Chisholm Trail Heritage Museum (CTHM). Mr. Oliver stated that he has presented his plans to the Cuero City Council and has submitted a formal proposal request for the closing of the eastern half of the 100 block of West Courthouse Street for the purpose of creating a "pocket park" and pedestrian open space between Cuero's historic Knights of Pythias Hall and Wm. Trautwein building. CTHM is working with Fisher-Heck Architects to develop a master expansion of the exhibit area and community facilities that will be located on the second floor of Trautwein building. These buildings, located at 220 and 222 N. Esplanade, were formally known as the Cook & Day Motor Company and the Wm. Trautwein buildings. The total expansion is estimated to be 15,500 sq. ft. The Chisholm Trail Heritage Museum is requesting that the CDC keep their major project in mind for upcoming grant opportunities.

# CONSIDER AND ACT UPON AN APPLICATION FOR MAIN STREET HISTORICAL DISTRICT FAÇADE PROGRAM FOR THE CHISHOLM TRAIL HERITAGE MUSEUM

Pursuant to Mr. Oliver's presentation on the expansion of the Chisholm Trail Heritage Museum, the Board of Directors voted to support the Main Street Historical District Façade program for repurposing the façade of 220 N. Esplanade Street to its original state by utilizing historical photographs. This project will include: closing the opening

that is currently the garage door opening, replacing the brick base and window above, repurposing the transom lights, and replacing the aluminum dividers with wood trim.

## CONSIDER AND ACT UPON THE POSSIBILITY OF ADDING HOTEL/MOTEL CLASSIFICATIONS TO THE CDC'S COVID-19 ASSISTANCE GRANTS

Mr. Seiferman reported that there has been an interest in applying for the CDC's COVID-19 grant applications by a local non-sales tax producing hotel. Although the hotel does not collect sales tax, Mr. Seiferman saw it pertinent for the Board to consider extending the applications because the hotel/motels bring business to Cuero.

Mayor Meyer questioned if the Board planned to consider including RV parks as part of the expansion of business classifications.

Mr. Scott questioned if RV parks collect hotel/motel taxes. Mayor Meyer stated some RV parks do collect sales tax and a man camp located in the ETJ also collects sales tax due to food and beverage sales.

The Board agreed that the hotels/motels and RV parks have an impact on sales within the community and expanded the COVID-19 grant applications to include these categories.

- Sales Tax Comparisons A copy of the sales tax revenue report was included in the Board package. It was reported
  that the sales tax remittance has increased by 16.54% for the calendar year and has increased by 6.66% for the fiscal
  year.
- 2) Community Leaders' Meeting Mr. Seiferman noted that the Community Leaders' Meetings will remain cancelled until further notice due to COVID-19.
- 3) Discuss upcoming conferences/meetings Mr. Seiferman noted that most of the upcoming in person Economic Development conferences, committee meetings, and courses have been cancelled and rescheduled to be held in virtual venues. Those courses will include: TEDC's Annual Conference, TEDC's Introduction to Economic Development, NREDA's Annual Conference, and the IEDC's CEcD certification course. An in person Texan of the Year Dinner will take place on September 3, 2020 in New Braunfels as part of the Texas Legislative Conference.
- 4) December Events Committee The DEC met on Wednesday, August 26, 2020 where nominations of officers were recommended. Those elected were: Chair Pat Villa, Vice-Chair Kay Lewis, Secretary Samantha Bayfus, and Treasurer Alton Meyer. A Christmas display was presented to Kay Lewis in honor of her numerous years of dedication to Cuero's Christmas in the Park.
- 5) Current Projects Mr. Seiferman reported that the CDC is coordinating with the Cuero Chamber of Commerce and Cuero Main Street Department to bring YOLO Texas, a television show that travels across the Lone Star State each week featuring sights, sounds, events, fairs, festivals, unique cities and towns, and seasonal happenings available throughout Texas any given time of the year. The CDC has been asked to split the cost of the television show and their portion will be \$1,066.66.
