### I. CALL TO ORDER

President Richard Weber called the meeting to order at 5:00 P.M.

### III. MONTHLY FINANCIALS

Mr. Scott gave the financial report for the period ending October 31, 2020. Mr. Scott mentioned that the financials are preliminary due to the end of year adjustments that may occur. A complete set of the financials will be presented at the November meeting. Mr. Scott also mentioned that he is working with the City of Cuero Finance Department to reconstruct the monthly financial status page.

Mayor Meyer questioned the total cost of training that the CDC Executive Director has taken to date and what the salary of the CDC Executive Director was. Mr. Scott mentioned that the end of year audit report has not been complete and that the final number would be a part of the end of year financials. Mr. Seiferman noted that his current salary is \$85,000.00.

### IV. BUSINESS

### CONSIDER AND ACT UPON AN APPLICATION FOR COMMUNITY SERVICES PROGRAM FOR CUERO BASEBALL ASSOCIATION FOR TEENS

Mr. James Mills thanked the Board for their time and consideration. Cuero Baseball Association for Teens (CBAT) is a non-profit that is comprised of parents to high school aged baseball players. Mr. Mills expressed his concerns for the dire need of field renovations to the Cuero High School baseball field. The goal is to remove the lips in the field for the safety of the players, renovate the home plate and pitcher's mound, and to add sod to help with the drainage issues on the field. Upon completion of these improvements, the Board will add new seeding to the field and a new irrigation system.

Mr. Scott questioned if some of the improvements included in the application are regular routine maintenance to the field. Mr. Mills said yes, but the irrigation system has not been touched in years, so these routine improvements would be necessary along with the new improvements.

Mr. Scott questioned where the funding is received from for CBAT. Mr. Mills noted that all funding is received from concession stand sales and also the outfield donation signs.

Mayor Meyer questioned if CBAT had reached out to Cuero City Manager, Raymie Zella to ensure that all contract requirements were being followed, as per their interlocal agreement. Mr. Mills mentioned that he was unaware of the contract amongst CBAT and the City of Cuero, but he would be sure to get the City Manager's approval, upon completion of these improvements. Mayor Meyer noted that per the agreement, City Council approval was necessary to do any renovations to the baseball field, which is City owned property.

Mr. Weber commended CBAT for their efforts in providing an exceptional field to the Cuero High School baseball team and suggested that the CDC Board approve the application with the exception that the Cuero City Council approve these improvements for CBAT.

Mr. Burns noted that his plans are to replace all of the awning braces to his building on the corner of Main Street and Gonzales Street to avoid the awning potentially falling down and damaging the remainder of his building. Mr. Burns mentioned that the braces to the building have rusted through various parts of the awning that compasses the whole building. The awning will be re-leveled, rotten wood will be repaired, and re-calking on and above the awning to prevent leaks will be done to Mr. Burn's office at 206 E. Main St. The façade on Main and Gonzales Streets will both also be repainted.

Adding these improvements to the arena will be a great asset to the Cuero Municipal Park and will enable the Cuero Livestock Show, Inc. to hold additional festivities at the arena. The Cuero Livestock Show, Inc. has not met with Cuero City Manager, Raymie Zella and they have not had approval by the Cuero City Council.

# HEAR REQUEST FROM CITY OF CUERO PARKS DIRECTOR, DAVID DANISH REGARDING PROPOSED FUTURE PLANS OF THE CITY OF CUERO MUNICIPAL GOLF COURSE

Mr. David Danish thanked the Board for their time and consideration of his proposed future plans of the City of Cuero's Municipal Golf Course. Mr. Danish mentioned that pursuant to the CDC Board's interest in assisting with the golf course renovations, he and Mr. Russell Goebel have comprised data for the Board. The total project cost is anticipated to be around \$500,000.00 and the goal of the Advisory Board is to complete this project in around three years.

Mr. Goebel presented the Board with past statistics of the Cuero Municipal Golf Course and noted that he would expect to see an increase in both memberships and tournament participants with these proposed improvements to the golf course. Mr. Goebel noted that the current membership fee is \$150, but he could foresee this amount being moved up to \$450-\$600 if the course is completely renovated.

The CDC Board suggested that the Mr. Danish submit a Major Projects grant application in the future and the Board would consider adding the Park's Improvements line item back to their budget.
