President Tyler McClellan called the meeting to order at 12:06 P.M.

III. BUSINESS

CONSIDER AND ACT UPON BUDGET AMENDMENT #1 OF THE FY 2023-2024

Mrs. Cromeens mentioned that a new draft of Budget Amendment #1 was sent to the Board due to minor adjustments. It was noted that the amendment is shown as 2 and 3 on the handout, but this was the only amendment to the current fiscal year.

The proposed Budget Amendment #1 included the following adjustments:

- Moving money to the Enterprise Fund allocation and to the NestFresh line item, as these two are shown combined in the Enterprise line item as \$848,000.00
- \$750,000.00 was allocated to NestFresh
- \$98,000.00 has been allocated to Stir Soda Shoppe from the Enterprise Fund
- NestFresh has been paid \$750,000.00 to date instead of the listed \$250,000.00
- Additional line items included minor adjustments to the expenses to budget the balance

Lynn Falcone questioned where the money was being moved from to cover the expenditures that were noted in the amendment. Mrs. Cromeens noted that an example included the \$16,000.00 that was taken from the website updates and maintenance line item because this item was not utilized during the fiscal year, the account was zeroed out.

President McClellan questioned the format of the presented amendment and noted that he too, did not understand where the revenue was generated from to cover the expenses in budget.

It was suggested that Mrs. Hawes the City of Cuero Finance Director explain the proposed changes of the amendment at a later time and that the Board recess for the remainder of the lunch period.

MR. MCCLELLAN CALLED THE MEETING TO ORDER FROM RECESS AT 4:00 P.M.

PRESENT: Tyler McClellan (via Zoom), Constance Donels (via Zoom), Lynn Falcone (via Zoom), Mayor Emil Garza (in person), Brad Kocurek (via Zoom), and Ben Zimmerman (via Zoom)

GUESTS: Connie Hawes, City of Cuero Finance Director (in person)

Mrs. Hawes noted that the amendment was requested as there are negative numbers running on the Cuero Development Corporation's (CDC) books. If the books were presented to the auditors in this position, one would assume that the finances were not being monitored in a timely manner. Although the budget was approved with the included revenue, the CDC did not stay in the means of the presented budget, therefore requiring the amendment prior to the end of the fiscal year.

Mrs. Cromeens noted that NestFresh was budgeted \$1million in the current budget. They have provided receipts for their payment of \$750,000.00 but have not turned in collateral for the additional \$250,000.00 payment. Mrs. Cromeens did mention that the job requirements have been met, per the plant manager.

Mrs. Hawes stated that although the amendment seemed to put the CDC over budget, they would actually end the year under budget and will transfer around \$174,200.00 to their fund balance. Mrs. Hawes reiterated that the amendments are done periodically by the City and are not uncommon.

The proposed Budget Amendment #1 included the following adjustments:

- · Adding revenue to the community donations
- Adding revenue to the display donations
- Adding revenue to the insurance reimbursement line item due to the flag being damaged

The proposed Budget Amendment #1 included the following adjustments:

- Adding revenue to exit treats line item
- · Adding revenue to the hot chocolate line item
- Adding revenue to the meals line item
- Adding revenue to the hardware line item
- Adding revenue to the other miscellaneous supplies line item
- Adding revenue to the December Events display purchases
- Adding revenue to the Christmas displays purchased by the public
- Adding revenue to the infrastructure line item
